

## **Cross Creek Ranch Give Back Build Hope Official Rules**

**MUST CONTRACT ON A NEW HOME IN ORDER TO PARTICIPATE. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.**

Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules.
