#### PAYING YOUR ANNUAL ASSESSMENTS:

As you know, the assessments became due on January 1st this year. The assessment provides for services in the community such as code enforcement, upkeep of the amenities (pool, fitness center, sports park, and lakes), and landscaping just to name a few. Every owner has an obligation to pay the annual assessment. Please note, if you did not receive a statement, you must contact C.I.A. Services immediately to confirm your balance and ensure it is paid on time. Not receiving a statement is not considered a reason for waving fees. All statements were mailed out in October of 2020. This included an annual assessment letter, payment options, collection policy and payment plan information.

February 1st, a \$40.00 late fee will be applied to all unpaid accounts. If your account remains delinquent, a late fee of \$60.00 will be applied on March 1st. In April, an attorney will file a Notice of Lien Affidavit and a Lien fee will be placed on the delinquent accounts. In May, the Board will consider sending accounts to the Association's attorney to begin legal collections efforts. All costs incurred and legal fees will be charged back to the account. Finance charges are applied on the last day of each month.

If you did not pay the assessment in full by the January 1st due date, you may follow the installment payments with the coupons that were enclosed with your statement; note, the coupons do not include past due balances on your account, if any. If you choose to mail your payment, please ensure it is in our office by the due date, postdated checks or envelopes are not accepted. The online payment options allow you to take advantage of the multi-payment option or schedule a one-time payment as well. Online payments can be made by credit/debit card or eCheck; please note that the Association's bank collects a convenience fee for all credit/debit card transactions (the amount of this fee is determined by the bank and we have no authority to set the fee amount and cannot waive, decrease, or amend the fee in any way). ## HOW TO ACCESS Amenities

The new Cross Creek Ranch Amenity Access and Gate Entry System is live now! This will allow you to access amenities with your smartphone or key fob.

Your mobile credential app is not linked to the My Cross Creek Ranch App, but through an app called "Conekt".



#### Step 1: REQUEST ACCESS ONLINE

Once you complete the Amenity Access form online, (either through CIA Services website or the CCR app) you will receive an email confirmation that your request has been received. A separate email will be sent with your amenity access information with instructions on how to proceed. TIP: Check your spam folder for the email.

NOTE: While you await your confirmation for amenity access, make sure to request your Resident Login on the CCR app. It can be found in the app store or Google Play Store. You can also access the web version of the app by visiting www.MyCCRanch.com.





#### Step 2: GETTHEAPP

(Skip this step if you requested only a key fob) When you receive your amenity access information email you will use your 16 digit code or QR code within the attachment to upload your mobile credential to the **CONEKT** app.

Note: once you upload your mobile credential, your mobile device is active! If you did not request a mobile credential, you are not required to download this app. If you requested a key fob please allow time for the postal service to deliver your device.





#### Step 3: ACCESS YOUR AMENITIES

You will be able to use your smartphone (once you have downloaded and connected your credentials to the **CONEKT** app) or key fob to scan in with the device reader.

## Once you have a Resident Login on the CCR app, here is how it works.





#### STEP 1:

In your community app, go to COVID-19 Amenity Pass. You will be prompted to sign the waiver and release - after you confirm your email you will be redirected to step 2.

#### STEP 2:

View the available timeslots for the desired amenity and select the timeslot card that you wish to schedule. Once you've identified the correct timeslot, request your pass and indicate the number of individuals in your party.

Once you have completed this process, you will receive an email confirmation, push notification, and your amenity passes will be available to you on the home feed of the app.

### HOW TO USE YOUR PASS

1

10 minutes prior to the beginning of your start time, you will receive a push notification reminder<sup>®</sup> to your device.

2

10 mins prior to your end time, you will receive a push notification asking you to prepare to leave the amenity.

At the expiration of your amenity pass, please exit the amenity in preparation for the next group of residents.

#### HAVE YOU EVER THOUGHT ABOUT ADDING FOAM ROLLING TO YOUR WORKOUT ROUTINE?

Foam rolling is one way to help relieve tension in the connective tissue that stretches over and through your muscles also known as the fascia. When you properly add pressure on a foam roller it can help break up the uncomfortable- oftentimes painful knots and adhesions in your muscles. Foam rolling before a workout along with static stretching for your overactive or tight muscles and dynamic stretches to activate weaker muscles can directly improve the quality of your workout. Addressing those muscle imbalances (weak muscles/ overactive muscles) can help with injury prevention while also helping to improve mobility, flexibility, and range of motion in your exercises.

Using a foam roller to address delayed onset muscle soreness (DOMS) can also help with recovery by breaking up tight knots and relieving the soreness in muscles. You may feel some discomfort while applying pressure on a muscle knot or a sore tender spot, but be sure to hold the pressure for a minimum of 30 seconds to be effective.



Taking time to implement foam rolling into your routine may be beneficial to your overall mobility, flexibility, muscle tightness and soreness. If you're new to foam rolling, talk to a personal trainer and we can give you a quick demonstration on how foam rolling can be a new tool to add to your workout routine.
